- (a) Haang sithy tooski eh ing saameyaw midnimithy qarangki ;
- (b) Haang khuseyty hariirithy dowligi ii amnigy qarangki, tusaale ithimthy qalabky sithy, argigihisithy ii tuug-maanye;
- (c) Haang khuseyty hormarki, hanaaneyawki ii maamulki dhaqaalegi dalki;

(h) Arrimo guud haang sithy tooski eh ing saameyaw ing ku bathang hal Dowlo-goboleed amy dhamaang tiyo ama dalki oo dhong, inii hoos kooyang taha awootho wethaagi eh oo federaalki.

4. Awootho Angshuuro

Dowlo-goboleeyithy inii weeldhithang awood yo ki aruuriyang angshuuro si wal-tar-leh liing ku arurii kori heer deegaang, isli madaasni muhiim ing haayni ini dalki oo dhong angshuur iku mid e luku qaathy.

Xukuumadda Federaalki wali awood ing leta ini angshuur ku qaadi ilo qarangi ii atheegyidy sidy angshuurti wal ha dijiyowki, taas o si wal-tar-le liinku arurii kori heerki qarangi ami meelo ama meelo muhiimki eti ini angshuur isku mid eh luku qaadi liki dhagi dalki oo dhong.

Arrimo kalà ee liing baahangyi ini li tih-gilii wali ku mid aha hoo ling ogolathi Dowlo-goboleed ini qaathang angshuuri qaas eh o taas ku dha abuuri korti Dowlo-goboleed sinaang la'aang doring.

Jadwalki 3aad: Habra'a Doorishooyingki Mathywiinagi (kang walii quseeye nithaamdkii baarlimentaaqi eh shaleethis)

Musharrah kasti oo ing tartimaw jagathi Mathywiininithy inii lahaki maga'aabi qoraal yo sahiheng inky yaraang tumung hubnood oo ku tirsing Golaga Shacabka waani ini haysithy ingki yaraang taageerithy ergithy hal Dowlo-goboleed oo ku mid eh Golaki wakiilatha Dowlo-goboleed.

Doorishithy Mathywiinagi wali liki qobothey too ami walk u badan kal-fidhiyi wadi-jir e oo weeldhithaayang lamady Gola e baarlimentaaqi, walini shir-gudoomiyeey doorishithy Gudoomiyegi Mahkimiddi Dastuurigi. Etheyow mi dhii korti hoobi ing roogni inki yaraang 70% hubna ko kasti o ku mid eh lamaadi Gola.

Hubna Golaki Wakiilatha ee Dowlo-goboleed wali edsho ing dhiibithaayana si shaksi shaksi eh maani ing dhiibithayang kooH kooH ergi haang. Edbiyowki ini haatuu qarsoothy, waani inii maamulang Guddi Doorishi.

Hoo doorishithy 1aad qofni waayi eded ku bathang nun-ku-nus ededki hubna roogi, walii liing guthubeey wareeg oo ling qobothaw lamaadi qof o heli tirithy inki bathang ededki li bii.

Hoo lamaadi Musharrah oo wareegi lamaad helang ed isku mid eh, inii li qobothuu wareeg kalà isli madaasbi, hoo wareegi sedehaad yo markalà helang tiri eded isku mid eh, kal-fidhigi inii laha gebi-gebaayuu ilaa luku deeraw yoonki ha higi o li qobithaaw wareegi afaraad.

Hoobi lamaadi Musharrah helaang tiri eded siming [Fiiri: walii jeree habab badang o liki haliyaw aragti ahang is maraw laangtung o kalà haanas o kooshoni ing haayni kaamil. Guddigi walii aring-tung ing bangdhikeyy inii dadwiinaga haku tali biyang].
